## VACANCY CIRCULAR

Applications in the prescribed format are invited for filling up 2 (two) posts of Assistant and 1 (one) post of Junior Hindi Translator in the Regional Office of the Ministry of Environment, Forest & Climate Change, Shillong from amongst officials of Central /State Government Departments/ Union Territories/ Public Sector Undertakings or Recognized Research Institutions or Universities or Statutory or Autonomous Organizations on deputation basis. The eligibility criteria required for the posts can be seen at Annexure-I.

The terms and conditions of the candidates selected for appointment on deputation will be governed as per the conditions laid down in Government of India, Department of Personnel & Training O.M. No. 6/8/2009-Estt dated 17.6.2010 as amended from time to time.

The period of deputation will be initially for three years and is likely to be extended further as per the guidelines of DoPT. The Period of deputation including period of deputation in another ex- cadre post held immediately preceding this appointment in the same office or some other office/ Department of the Central Government shall ordinarily not exceed three years. The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the closing date prescribed for receipt of applications.

Applications of officials who are eligible and are willing to be considered for appendment on deputation basis and who can be relieved immediately after selection may be forwarded through proper channel along with their attached copies of ACR dossiers/APARs for the preceding Five years and Vigilance Clearance certificate, Integrity certificate and certificate to the effect that no minor/major penalty has been imposed on the officer during the last 10(ten) years, so as to reach the Dy. Inspector General of Forests (Central) & Head of Office, Ministry of Environment Forest & Climate Change, Regional Office, Lumbatngen, Shillong-793021.

The receipt of complete application form in the prescribed format (Annexure-II) for deputation should reach this office within 45 (forty five) days from the date of publication of this advertisement in Employment News. Applications without the recommendations of the Parent office/ Department, incomplete applications and applications received after the prescribed date or without ACR dossiers /APARs/Vigilance clearance, Integrity certificate and certificate to the effect that no minor/major penalty has been imposed on the officer during the last 10(ten) years will not be entertained.
