

VACANCY CIRCULAR

- 1. It is proposed to fill up the post listed in **Annexure-I** in the Integrated Regional Office of the Ministry of Environment, Forests and Climate Change at Lucknow from amongst official of Central Government or State Government or Union Territories or Public Sector Undertakings or Recognized Research Institution or Universities or statutory or autonomous organization on deputation. - 2. The terms and conditions of the candidates selected for appointment on deputation basis will be governed as per the conditions laid down in the Government of India, Department of Personnel & Training's OM No. 6/8/2009- Estt., dated 17.6.2010, as amended from time to
- 3. The period of deputation will be initially for three years and is likely to be extended further up to five years as per the guidelines of DOP &T. The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or other Office/ Department of the Central Government shall ordinarily not exceed Four (4) years for the post of Principal Private Secretary to DDGF and Three (03) year for the post of Junior Hindi Translator . The maximum age limit for appointment of deputation shall not exceed 56 (Fifty six) years as on the closing date prescribed for receipt of application.



G.S.R. 390.—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules regulating the method of recruitment to the post of Principal Private Secretary in the Regional Offices of the Ministry of Environment, Forest and Climate Change, namely:

- Short-title and commencement. (1) These rules may be called the Regional Offices of Ministry of Environment, Forest and Climate Change, Principal Private Secretary, Group 'A' post Recruitment Rules, 2018.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- Number of post, classification and level in pay matrix. The number of the said post, its classification and level in the pay matrix attached thereto shall be as specified in column (2) to (4) of the schedule annexed to these rules.
- Method of recruitment, age limit, qualifications, etc. The method of recruitment, age limit, qualifications
 and other matters relating thereto shall be as specified in the columns (5) to (13) of the aforesaid Schedule.
- 4. Disqualification. No person, -
 - (a) who has entered into or contracted a marriage with a person having a spouse living; or
 - (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to any of the said post;

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. Power to relax. Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with the Union Public Service Commission relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving. Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Other Backwards Classes, the Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

Note 2. - The Departmental officers in the feeder category who are in direct line of promotion shall not be eligible for consideration for appointment on deputation, and similarly, deputationists shall not be eligible for consideration for appointment by

promotion.

Note 3. - Period of deputation (including short-term contract) including period of deputation (including short-term contract) in another ex-cadre post held immediately preceding appointment in the same or some other organisation or Department of the Central Government shall ordinarily not exceed four years.

Note 4. - The maximum age limit for appointment by deputation (including short-term contract) shall be not exceeding 56 years as on the closing date of receipt of applications.
