6.1 Granting permission for import of Scrap tyres for 10 years for manufacturing of rCB (recovered Carbon Black) – Representation from M/s Birla Carbon SCM IndiaPrivate Limited, Worli, Mumbai

The applicant *vide* letter dated 10th October, 2024 stated that Birla Carbon is one of the leading global suppliers of carbon-based solutions. In India, Birla Carbon has become a partner in Finster Black Private Limited to manufacture and supply rCB at large scale to the Indian tire manufacturers looking for more circular raw materials. It is therefore requested to consider the original request of M/s Finster Black Private Limited for granting NOC for import of Scrap tyre for a 10-year period for a volume of 50,000 TPA.

The matter was last discussed in 138th EC meeting held on 23rd October, 2024 and the EC noted that, TRC in its 76th meeting after detailed deliberation/discussion recommended that the permission for import of 50,000 MT of Used tyre scrap in baled/multicut form for production of Recovered Carbon Black (RCB) which will replace the virgin Carbon Black in manufacturing Industry, may be granted initially for a period of 3 years on pilot basis to M/s Finster Black Private Limited with certain conditions and also recommended that while Expert Committee considered application for import may imposed additional conditions. The recommendation of TRC was approved in the Ministry by the competent authority and accordingly, import permission has already been granted to M/s Finster Black Private Limited for FYs 2023-24, 2024-25 and 2025-26 as per current policy and felt that there is no need to consider the request for grant of import permission for a period of 10 years at this stage.

Now, the applicant *vide* letter dated 25th November, 2024 has again requested the Ministry/Committee to reconsider the original request of M/s Finster Black Private Limited for granting NOC for import of Scrap tyre for a 10-year period for a volume of 50,000 TPA. Accordingly, the matter is placed before the EC.
