They shall have to pass one of the periodical typewriting test in English or Hindi held by Staff Selection Commission/Department of Official Language at a minimum speed of 35 w.p.m. in English or 30 w.p.m. in Hindi, unless exempted by the order issued by this Ministry in this regard.
