**ORDER**

**Subject: Allocation of Work to Minister of State in the Ministry of Environment, Forest and Climate Change - reg.**

(d) i. Zoological Survey of India(ZSI)


ii. Botanical Survey of India(BSI)

iii. International Centre for Integrated Mountain Development (ICIMoD)

iv. Govind Ballabh Pant National Institute of Himalayan Environment & Sustainable Development (GBPNIHSED)

(iii) Following matters shall be submitted directly to the Hon'ble Minister of Environment, Forest and Climate Change:

- a) All matters relating to Environment, Forest, Wildlife and CRZ Clearances and Policy issues pertaining to these clearances, whether on PARIVESH Portal or e-office.
- b) Constitution of EACs, REC, SEIAAs, SEACs and SCZMA.
- c) All VIP references addressed to Minister
- d) Any urgent immediate matter.
