2.5. M/s Saraswathi Rubbers, Suryapet, Telangana (F. No. 23/86/2023-HSMD)

The applicant has requested for the extension of validity period of permission granted for import of 11,150 MT of used Rubber Tyre Scrap/Tubes Scarp (B3140) *vide* letter dated 03rd October, 2023 by at least six months. The applicant was given permission in FY 2024-25 based on the production data of FY2023-24 *vide* letter dated 29th May, 2024 for import of 40,000 MT of Used tyre Rubber Scarp/tube scrap. The applicant has mentioned that they have almost imported and fully utilized it. So, the applicant requested to provide additional quantity. Domestic Quantity procured in the current FY 2024-25 (i.e. up to Jan, 2025) is 10,808/ MT and imported quantity was 45,088.65 MT. The amount paid towards electricity is Rs.374.07 lac.

AGENDA ITEM No. 6: ANY OTHER ITEMS WITH PERMISSION OF THE CHAIR

6.1. Request to consider validity period of 2.5 years for proposed NOC's of 3 years or alternatively issue the 3 years NOC for the year beginning from 01.04.27 instead of 01.04.2026 – Representation from M/s Finster Black Private Limited, Raigad, Maharashtra.

M/s Finster Black Private Limited, Raigad, Maharashtra *vide* letter dated 12th March, 2025 has requested to consider validity period of 2.5 years for the of 3 years or alternatively issue the 3 years NOC for the year beginning from 01.04.27 instead of 01.04.2026.

It is to mention that based on the decisions of 91st TRC meeting held on 28th January, 2025, the EC in its 142nd meeting held on 28th February, 2025, recommended import of

50,000 MT of old/used rubber tyre scarp/tube scrap (B3140/B3080) for manufacturing of rCB (recovered Carbon Black) which will replace the virgin Carbon Black in manufacturing Industry, for the FYs 2026-27, 2027-28 and 2028-29 each subject to some conditions. Further, TRC also recommended that 18 months validity period of import permission will be reckoned from 1st April of the FY for which permission is given.

Now, the applicant has requested to consider validity period for either 2.5 years for each FY instead of 18 months or grant permission for 18 months commencing from FYs 2027-28, 2028-29 and 2029-2030.
